SECTION 1. PERMIT DENIAL


In compliance with the Wyoming Environmental Quality Act, Wyoming Statute (W.S.) § 35-11-101 through 1104, specifically 301(a)(i) through 301 (a)(iv), Laws 1973, Ch. 250, Section 1; W.S. § 31-11-313, Laws 2008, Ch. 30, Section 1; and Wyoming Water Quality Rules (WWQR), Chapters 24 and 29, the Class VI Underground Injection Control (UIC) permit application submitted by

North Shore Exploration and Production, LLC, 105 Edgeview Drive, Suite 400, Broomfield, CO 80021

for a Class VI Carbon Sequestration injection well located in Section 31, Township 16 North, Range 119 West, Uinta County, Wyoming has been determined to be incomplete. WWQR Chapter 24, Section 5(a)(i) states that the Director may deny a Class VI permit if the application is incomplete. The permit application was submitted to the Wyoming Department of Environmental Quality Water Quality Division (WDEQ/WQD) UIC Program on December 1, 2021. After a review of the application, the UIC Program determined that the application was incomplete and submitted comments to North Shore Exploration and Production, LLC on March 8, 2022. Multiple working meetings were conducted between North Shore Exploration and Production, LLC, and the WDEQ to discuss the comments. North Shore Exploration and Production, LLC has not submitted a formal response to resolve the deficiencies to date. The WDEQ has not received any correspondence from North Shore Exploration and Production, LLC since April 28, 2023.

The UIC Program sent a letter to North Shore Exploration and Production, LLC soliciting a formal response to resolve the deficiencies on August 3, 2023 and requiring a response from North Shore Exploration and Production, LLC by August 21, 2023. As no response was received prior to August 21, 2023, the application remains incomplete; therefore, a Class VI permit cannot be authorized.

This permit denial consists of one (1) page with no attachments and shall become effective on the date signed by the Director.
