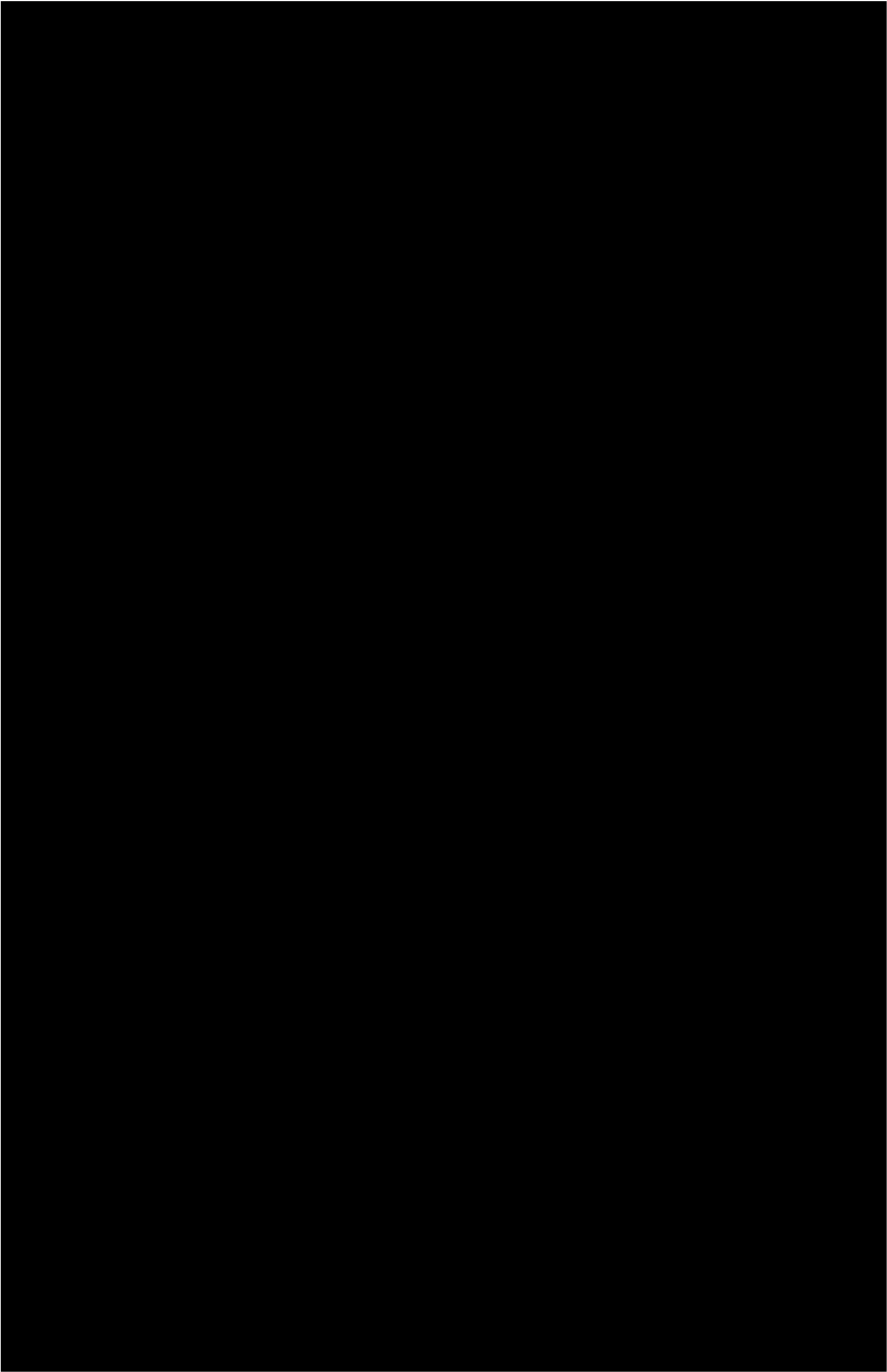
Denbury will use the materials and methods noted in Tables 1 and 2 to plug the wells pursuant to CFR 40 146.92.

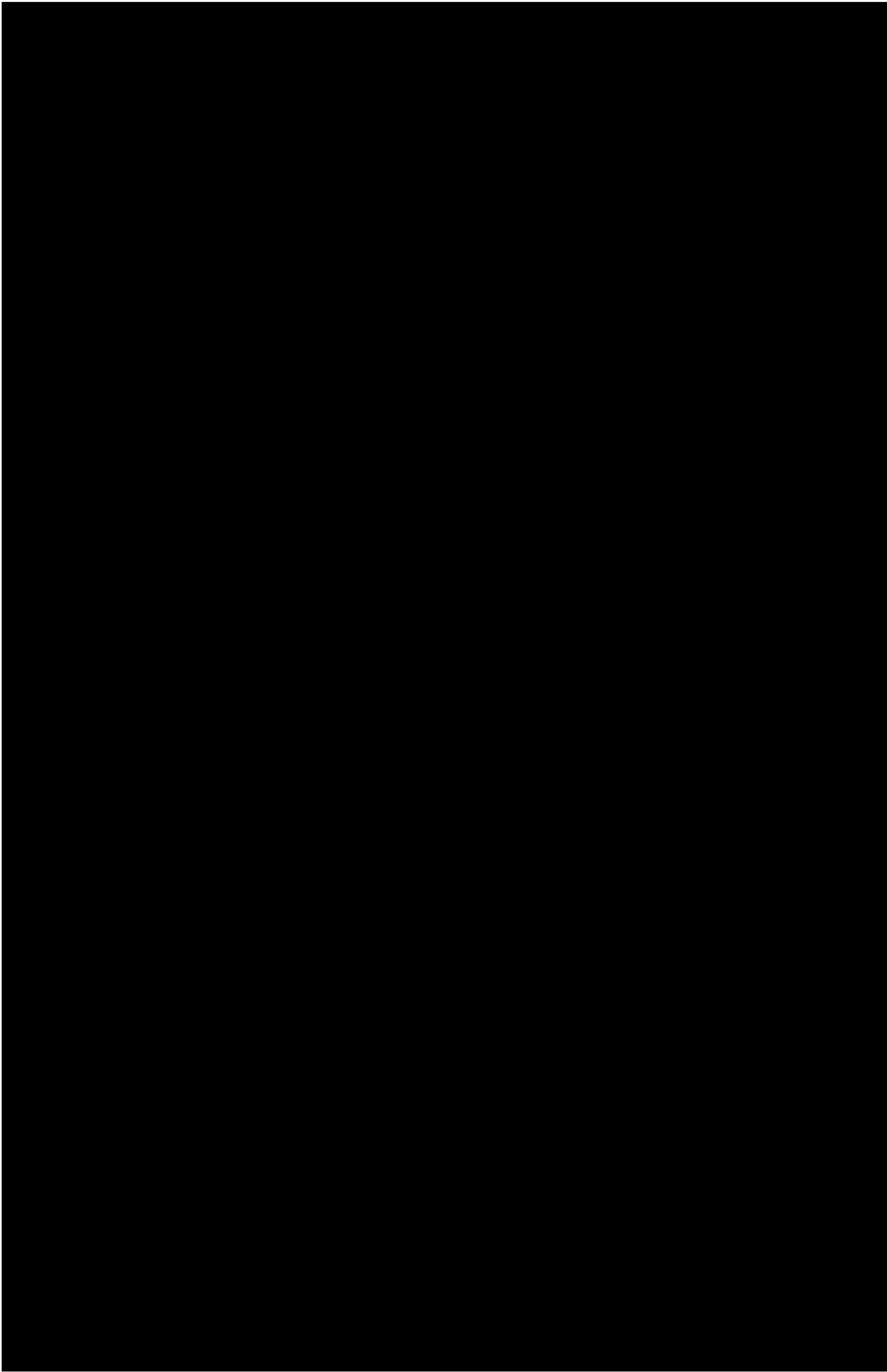


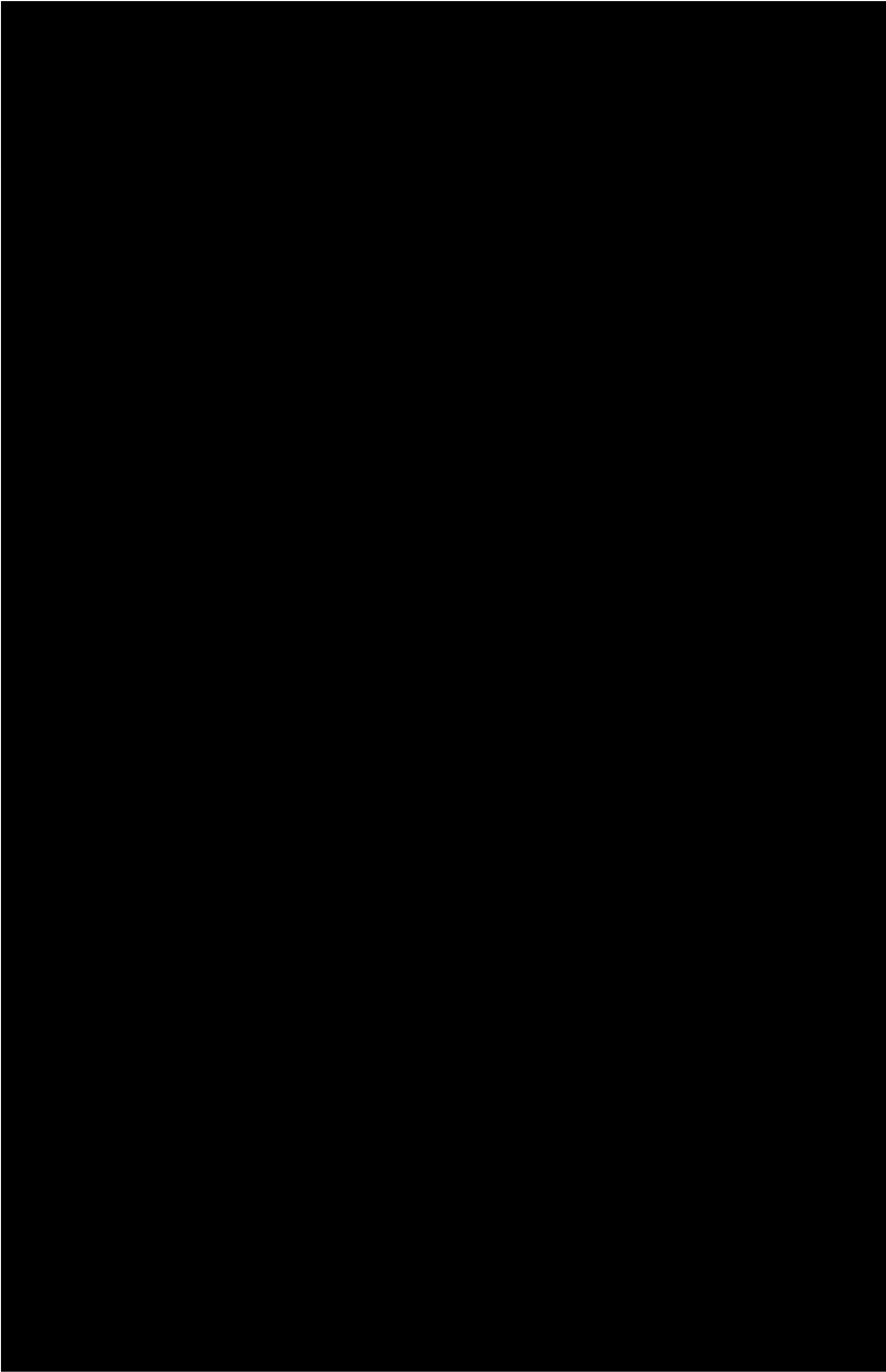













5.0 NARRATIVE DESCRIPTION OF PLUGGING PROCEDURES

5.1 NOTIFICATIONS, PERMITS, AND INSPECTIONS

EPA UIC

- In compliance with 40 CFR 146.92(c), Denbury will notify the regulatory agency at least 60 days before plugging the well and provide updated Injection Well Plugging Plan, if applicable.
 - In compliance with 40 CFR 146.91(e), Denbury will submit a plugging report to the regulatory agency within 60 days after plugging. Denbury will retain the plugging report for 10 years following site closure.
 - Should any unforeseen circumstances occur that necessitate a change in the plugging plan, Denbury will contact the Director for approval of the amended plan and incorporate the amended plan into the permit to satisfy 40 CFR 146.91(e).
