THIS MEMORANDUM OF CARBON STORAGE AND SURFACE EASEMENT AGREEMENT (the "Memorandum"), entered into effective as of June 26, 2023 (the "Effective Date"), is to give notice of that certain Carbon Storage and Surface Easement Agreement dated as of the Effective Date, by and between **Z&T Cattle Company, LLC** ("Grantor"), whose address is 1501 South Mary Street, Pecos, Texas 79772 and **Milestone Carbon, LLC** ("Grantee"), whose address is 15721 Park Row Blvd., Suite 200, Houston, TX 77084.

1. Grantor and Grantee entered into that certain Carbon Storage and Surface Easement Agreement (the "Agreement") dated as of the Effective Date, whereby Grantor granted unto Grantee an exclusive easement in and to certain subsurface formations for the purpose of storing carbon dioxide and incidental associated substances, along with certain rights to use the surface of the Property.
2. The real property covered by the Agreement consists of 10,872 acres of land, more or less, in Loving County, Texas, as described in Exhibit "A" hereto (the "Property").
3. The terms, conditions and covenants of the Agreement are set forth in the Agreement and are incorporated herein by reference as though fully set forth herein. Copies of the Agreement are on file with Grantor and Grantee.
4. This Memorandum may not be amended, changed or extended except by written instrument signed by all parties hereto.
5. This Memorandum may be signed in multiple counterparts, all of which, when taken together, shall be deemed one instrument.

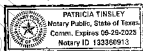
